




NITC Participation Growth During Last 3 Years

Incorporation under an Act of Parliament

The first reading of the CSSL Parliamentary Bill took place on March 22, 2012 in Parliament. The draft bill, No. 165, was gazetted and published by the parliament. Further, the draft Bill has been sent to the Ministry of Telecommunication and IT to have the Bill redrafted by the Legal Draftsman and to obtain Attorney-General's Certificate. The Second Reading of the Bill was moved by the Parliament on 21st June 2013 and referred to the Standing Committee B (Legislative); The Ministry is to provide the redrafted Bill for approval to the parliament.

The National School Software Competition (NSSC)

The National School Software Competition (NSSC) was conducted for the 25th consecutive year, in two stages: the preliminary round, a provincial level paper based competition, was held at 17 regional test centers on 30th August 2014. 871 students registered from 201 schools representing all 9 provinces. The final round, an on-line computer based competition, was held in Colombo with the participation of 31 students, selected from the provincial competitions. The Computer Society of Sri Lanka has been conducting this annual competition since 1990. One of the key objectives of the competition is to promote the IT knowledge and interest among the Sri Lankan school children.

The finals were held on 21st September 2014 at University of Colombo School of Computing. All 31 students were given two day training with food and lodging before the online exam and the following students were adjudged winners of the competition:

International Schools Software Competition (ISSC)

ISSC is an annual event, organized by the South Asia Regional Computer Confederation (SEARCC), that is being held in one of the member countries in the region with the aim of bringing out problem solving and programming talent in school students in a competitive environment, within international standards. This competition also provides an opportunity for students from the Asia Pacific Region to meet and exchange valuable experience in the field of ICT. The competition further provides opportunities for the young people of the region to acquire better awareness of culture, life-style and aspirations of each other's country, leading to social harmony in the region.

From the winners of the National Competition, students under 18 years of age have the opportunity of participating in the International Schools Software Competition (ISSC) organized by South East Asian Computer Regional Confederation (SEARCC).

The International Schools' Software Competition (ISSC) hosted by the Indian Computer Society (ICS) was held in Chennai from 9th to 12th October, 2014. The ISSC participating Sri Lanka teams were given another 2 day training at University of Colombo School of Computing. Six teams representing India, Papua New Guinea, Taiwan and Sri Lanka participated at this competition. Both India and Sri Lanka had two teams each competing while other countries were represented by one team. The duration of the competition, consisting of four programming problems, is two hours. The competition was held in C++ and Java.

The winner of the competition was Republic of China (Taiwan) team. Indian Team came in the second place while Sri Lankan Team A won the third place. Sri Lanka Team B won the fourth place.



IT Mastermind

This year's IT Mastermind programme was well organized together with ESoft as the strategic partner, and ITN Sri Lanka as the media partner. Applications were received in February 2014. Over 2700 students participated in the first round of the quiz that was held as an online test to select top 200 candidates during March 2014. These 200 candidates sat for the 2nd round of the quiz, which was held as a written examination in different provincial centres covering all districts during March 2014. 108 candidates were shortlisted for the preliminary rounds of the main competition that was to be broadcast on ITN. These 108 candidates contested in quiz competitions held at the Open University Recording studio, with live recording. CSSL Council and Fellow members and appointed personnel from ESoft served as judges. Mr. Faizal Bongso served as the quiz master. There were 18 preliminary live quiz competitions where 6 contestants participated. Each competition had 3 rounds. Winner and the 1st runner up of each preliminary competition, hence 36 contestants, were selected for the second live round of 6 competitions. Winner of each of the 2nd round live competition were selected for the Grand Finale, Winners were awarded certificates, medals, laptops and computer equipment for their respective schools. Quiz programme is being broadcast on ITN on Wednesday from 6.30 pm to 7.00 pm.



CSSL Dinner Dance “IT Blast”

For the first time in the history, the CSSL organized an IT Dinner Dance to give an unique experience to IT professionals. This Intimate evening was held in Waters Edge, Battaramulla one of the most prestige hotels with most popular entertainers. This signature event was an ideal networking opportunity.



Communication and Social Media Presence

Communication forms an important part of any organization. Typically, an organization needs to maintain strong internal and external communication with its stakeholders. Internal communications were fairly strong at CSSL over the years; however during this tenure we have further strengthened it by improving and timely updating the CSSL & NITC website, regular email updates to members, better use of CSSL email addresses and a review process for all membership emails. During 2014, external communications, especially the public relations aspect has been strengthened significantly. There were monthly press releases that were published in national newspapers and e-flyers highlighting various project activities. The national newspapers regularly published news items about CSSL activities. Digital media coverage of CSSL was improved during the year including the E-Newsletter; having a CSSL brand presence in all major social media channels (i.e. Facebook, LinkedIn etc.) in a synchronized manner.




CSSL Column in the Daily FT News Paper

The Computer Society of Sri Lanka maintained a separate CSSL column in the Daily FT Newspaper, to discuss matters relating to ICT professionals, ICT industry as well as to represent ICT professionals in the country. CSSL members were invited to provide any suitable content for this column.

CSSL organizes ICT training for Teachers in Sri Lanka with the support of Ministry of Education & Deutsche Bank

The Computer Society of Sri Lanka (CSSL), embarked on a number of initiatives to uplift the standards of ICT literacy among Sri Lankans. One such initiative is to provide necessary training on ICT skills for both students and teachers, who would be playing a key role in making Sri Lanka as an ICT hub in the region. A Teacher Training on Java Language for ICT teachers was successfully initiated in September 2014 with the support of Deutsche Bank. The program is conducted under the supervision of the Ministry of Education in Sri Lanka. The program is conducted in “Train-the-Trainer” format which would be beneficial for a number of teachers and students.



ICDL

The European Computer Driving License Foundation Limited (ECDL Foundation), based in Dublin, Ireland, is the worldwide governing body and licensing authority for the ECDL (European Computer Driving License) and the ICDL (International Computer Driving License), the global standard in end-user computer skills certification.

ICDL, the world’s most recognized IT skills qualification, is delivered in 150 countries, to 13 million people in 41 languages through 24,000 study centres. It is approved by academic and international experts from around the world.

The ICDL Asia Pacific Limited (ICDLAP), based in Singapore, is a fully owned subsidiary of the ECDL Foundation, and is the regional governing body and licensing authority for the ICDL (International Computer Driving Licence). During the period under review, 2 new center were accredited as Accredited Test Centres (ATCs) and 72 existing Accredited Test Centres (ATCs) were re-accredited. In order to streamline the accreditation process of ICDL, the following steps were taken in 2014.

- ▶ A MoU was signed between ICDL Sri Lanka & CSSL

- ▶ Re launch the “New” ICDL
ICDL Sri Lanka launched their new programme ‘New ICDL’ which is a major revision of the programme, developed to reflect technology changes and labour market requirements. The launch was held at the Waters Edge, Battaramulla on 4th September 2014, and was attended by Educators in the School, Professional, Higher and Technical Education sectors, Heads of HR and Training of Corporates and BPOs. Mr. Anura Dissanayake, Secretary of Education graced the occasion as the Chief Guest.
New ICDL is made up of a range of modules which provides a practical programme of up-to-date skills and knowledge areas, which are validated by a test. New ICDL enables learners to develop and certify their computer skills in the subject areas of their choosing and to the level that they need.

- ▶ Close monitoring of ICDL centers to ensure that the accreditation program is right on track

- ▶ Changes were made to the discount structure for multiple center registrations and collection procedure to increase the revenue.

CSSL Certification

Certification of ICT skills using an internationally recognized benchmark is extremely important for the ICT industry from multiple perspectives. The industry wide recognition of such a benchmark could drastically shorten the recruitment process, optimize training expenditure and provide a snapshot of the skills available within an organization.

CSSL Certification is offered in partnership with the Australian Computer Society (ACS), based on the SFIA (Skills Framework for the Information Age) competency framework. Any CSSL member could now apply to be certified in any of the 96 SFIA skills and 7 levels of responsibility defined in the SFIA framework. CSSL has six ACS trained evaluators who are now able to evaluate the candidates using the SFIA framework based on the evidence provided. This is an online process monitored and audited by the ACS to maintain a high standard and the consistency.

Certification of ICT skills using an internationally recognized benchmark is extremely important for the ICT industry from multiple perspectives. The industry wide recognition of such a benchmark could drastically shorten the recruitment process, optimize training expenditure and provide a snapshot of the skills available within an organization.

For the ICT practitioners, this provides a method to self assess the ICT skills and plan their career development for a target ICT role both locally and globally.

SFIA is an open source, two dimensional skills matrix developed in 1998, by the SFIA Foundation, a UK consortium comprising IET, IMIS, e-skills UK, and BCS. This framework is revised and updated constantly. The current version of the framework is version 5, which was released in December 2011.

Any CSSL member could now apply to be certified in any of the 96 SFIA skills and 7 levels of responsibility defined in the SFIA framework.



CSSL Awards 2014

The annual CSSL Excellence in ICT Awards will be held for the 2nd consecutive year in December 2014 at the Kingsbury Hotel Colombo.

These awards intend to encourage, recognize and celebrate the excellence in ICT practice by rewarding the best and the finest of ICT professionals. Being the premier organization dedicated to promoting and improving professional standards in the information communication technology sector, the CSSL, will be awarding three awards for 'Emerging ICT Leader of the Year', 'Female ICT Leader of the Year' and 'ICT Leader of the Year'

CSSL President Appointed as President of South East Asia Regional Computer Confederation (SEARCC)

The President of CSSL, Mr. Ajith Salgado was appointed as the President of the SEARCC this year.

SEARCC is a forum of national Information and Communication Technology professional societies in the Asia Pacific region that promotes IT professionalism across the region.

The CSSL has been a member of the South East Asia Regional Computer Confederation (SEARCC) Since 1986. During the year under consideration the CSSL has played a vibrant role in SEARCC activities, including the International School Software Competition and SEARCC Conference.
