### Society 5.0 Takes Center Stage at NITC



The National Information Technology Conference (NITC) 2024, chaired by **Udesh I W Seneviratna**, achieved a historic milestone by surpassing 1,000 registrations for the first time in its 42-year history, with a total of **1,163 registrations**. # **Digital Investment Summit 2024**

The Sri Lanka Digital Investment Summit (DIS) 2024, hosted by the Computer Society of Sri Lanka (CSSL), marked a crucial step in leveraging digital innovation for national economic recovery. Held on November 26, 2024, at the Shangri-La Hotel Colombo, the event brought together policymakers, industry leaders, and investors, including Lanka Angel Network, MasterCard, hSenid Ventures, Palladium Group, Ironwood Capital Partners, and PanAsia Bank.

The summit featured notable speakers like Dr. Ajantha Atukorale, President of CSSL, Mr. Damith Hettihewa, past CSSL president, and Ms. Dinali De Silva, CEO of Lanka Angel Network. They addressed an audience of investors, entrepreneurs, and startup enthusiasts, fostering collaboration between 20 digital startups and scale-ups with angel investors and high-net-worth individuals.

Running parallel to CSSL's National IT Conference (NITC) 2024, the summit is a pivotal platform for addressing economic challenges, such as the Balance of Payment crisis, through technology-driven solutions. Launched in 2022, DIS continues to drive initiatives to achieve Sri Lanka's ICT export goal of USD 5 billion by 2030.

# **CSSL Boardroom Gets a Modern Makeover**



# **CSSL Tech Talk - Session 02 for 2025**

The second CSSL Tech Talk for 2025, titled "Why Law Matters in Coding," took place on 30th April 2025 at NIBM, Colombo 07, continuing the series' mission to bridge technology, governance, and professional excellence. The event drew software developers, cybersecurity practitioners, and IT leaders into a critical dialogue on the growing intersection between code and law.

Mr. **Udaya Ranasinghe**, Cybersecurity Engineer at LB Finance PLC, led the session with an insightful and practical exploration of the legal landscape surrounding software development. His talk emphasized the necessity for developers to understand and incorporate legal and compliance requirements into the software lifecycle, particularly in today's interconnected and regulated environments.

Key highlights from the session included:

- Sri Lankan Regulatory Framework: Coverage of the Personal Data Protection Act (PDPA) and the Computer Crimes Act, with relevance to software engineering practices.
- International Compliance Standards: Discussion on GDPR, PCI DSS, and their implications for global software deployment.
- DevSecOps Integration: Strategies for embedding security and compliance checks within the software development lifecycle to enhance product trustworthiness.

The talk stressed that understanding legal requirements is not just a task for legal teams—it is a shared responsibility among developers, architects, and security professionals. With cybersecurity and data protection becoming critical board-level concerns, this session reinforced the need for legal literacy within development teams.

🔍 Takeaway Message:

Security and compliance must be "built-in," not "bolted-on." Legal awareness in coding is a cornerstone of resilient, trustworthy, and globally acceptable software products.




### **GenZ: Reading without Boundaries**
